§ 1

§ 2

The Plenipotentiary for Students of the field of study should represent the interests of students of a given field of study towards the University authorities in the scope/field:

- a) organizing of the didactic process,
- b) social benefits,
- c) organizing cultural and social life.

§ 3

The duties of the Plenipotentiary for Students of the field of study should be particularly involved:

- a) provide students with basic information on the organization of studies, the study rules and regulations of the university,
- b) assist in organizing the election of the head of the year and the head of student groups,
- c) help and advise on the problems of the students' personal problems,
- d) inform the university authorities of the cases of the students in question,
- e) assistance in resolving conflict situations,
- f) receive comments and opinions on the course of the teaching activities from the class coordinators, the staff involved in the course of the teaching activities and the students involved,
- g) participate in committee exams and assignments,
- h) assist in organizing university events, in particular for matriculation and graduation.

§ 4

The employee is obliged to organize the following student meetings:

- a) information meeting for first-year students starting their studies,
- b) meetings to select subject to choose from,
- c) meetings to select specialties.

§ 5

The Plenipotentiary for Students of the field of study is obliged to cooperate with the Dean's Office and the Plenipotentiary for Students for the Vice-Rector for Education in the scope of fulfilling the obligations of students specified in the Study Regulations.. At the end of each academic year, the Proxy is obliged to submit a report on the activities performed to the Proxy for Students for the Vice-Rector for Education. The report should be submitted by October 15 of the following academic year at the latest. Template of the report in the attachment to the order.

§6

The Plenipotentiary for Students of the field of study may be entrusted with the performance of other tasks commissioned by the University authorities or the Manager of the field of study, concerning students of the field in which he/she acts as the Plenipotentiary.

§7

In order to improve the information flow process, the Plenipotentiary for Students of the field of study creates a telephone and e-mail database of the head of the years and student groups, takes care of its updating and forwards it to the Plenipotentiary for Students for the Vice-Rector for Education, the Dean's Office and the Didactics Office.


§8
