

100% or 50% discount for the last semester of studies Promotion Regulations

for the Wrocław Business University of Applied Sciences

§ 1 General provisions

- 1. These Regulations define the rules, scope, and conditions of participation in Wrocław Business University of Applied Sciences Promotion "100% or 50% discount for the last semester of studies", hereinafter referred to as the "Promotion".
- 2. The Promotion is organized by Wrocław Business University of Applied Sciences with its registered office in Wroclaw, hereinafter referred to as the "Organizer".
- 3. Participation in the Promotion is voluntary. Taking part in the Promotion means that the participant gives his/her consent to the terms and conditions of the Promotion, defined in these Regulations.
- 4. A Participant of the Promotion may be a person who meets the conditions for participation specified in §2 of these Regulations.
- 5. The Promotion runs from November 22, 2023 until December 31, 2023.

§ 2 Rules for participation and the course of the Promotion

- 1. The Promotion is addressed to the candidates who want to commence their Bachelor's or Master's degree studies at Wrocław Business University of Applied Sciences in the Spring semester of 2023/2024 academic year in English and will submit a full set of the required application documents and pay the required fees by December 31, 2023.
- 2. The Promotion covers the citizens of all countries in the world except Poland. This promotion also exclude the candidates who transfers for higher semesters of studies.
- 3. Candidates for Bachelor studies who pay the required fees, submit a full set of the required application documents before the deadline (December 31, 2023) and pass the interview (if required) will get 100% discount for the last semester tuition fee of their studies. Candidates for Master studies who pay the required fees, submit a full set of the required application documents before the deadline (December 31, 2023) and pass the interview (if required) will get 50% discount for the last semester tuition fee of their studies.
- 4. Studies will be conducted in Wroclaw.
- 5. The Promotion does not cover the cost of accommodation, meals or transportation.
- 6. Conditions of resignation from studies are described in the contract on the amount and conditions of charging tuition fees for study.





- 7. If the Participant of the Promotion does not commence studies in the Spring semester 2023/2024 or resigns from studies at Wrocław Business University of Applied Sciences, he/she will not be able to participate in the Promotion anymore.
- 8. The Promotion is not combined with any other promotional offers of Wrocław Business University of Applied Sciences.
- 9. Proper implementation of the Promotion is supervised by the Organizer's staff, who will, if necessary, help in resolving doubts regarding the Promotion rules, as well as the provisions and interpretation of its Regulations.

§ 3. Complaint proceedings

- 1. Complaints regarding the Promotion must be submitted in writing to the Organizer's address or otherwise invalid.
- 2. A written complaint should contain the name, surname, exact address of the person participating in the Promotion as well as detailed description and indication of the reason for the complaint.
- 3. Complaints will be considered within 14 days from the date of their receipt by the Organizer.
- 4. The decision regarding the complaint is the final and binding position of the Organizer.

§ 4. Final provisions

- 1. The Regulations are available on the website www.wab.edu.pl and in the Recruitment Office.
- 2. The Organizer reserves the right to change these Regulations, provided that such a change does not violate the acquired rights of the Participant. Information on any changes made to the Regulations will be provided at the Internet address indicated in section 1 of this paragraph sufficiently in advance.
- 3. Acceptance of the Regulations is synonymous with consent to the use and processing of the Participant's personal data by the Organizer in accordance with the Act of 29 August 1997 on the Protection of Personal Data (Journal of Laws of 2002 No. 101, item 926 as amended) for the purposes of conducting the Promotion. The Administrator of personal data provided within the Promotion is the Organizer.
- 4. The Promotion Participant has the right to access and amend his/her data referred to in section 3.
- 5. Any disputes arising out of the performance of obligations related to this Promotion will be resolved amicably. Any disputes, which will not be resolved by way of negotiations shall be settled by the court having jurisdiction over the University's registered office.
- 6. In all matters not covered by these regulations, the provisions of Polish law shall apply. All materials made on the basis of these Regulations are for information purposes only.
